Index and overview of findings



Data Source

This report is based on the experience of 975 people. Feedback has been obtained from a variety of sources, including general engagement and comments posted online (including Care Opinion, NHS and social media). More on page 4.



Overall Satisfaction

Satisfaction has improved by 1% this quarter, standing at 65% positive, 34% negative and 1% neutral.

Feedback suggests people receive good quality, compassionate treatment and care on the whole, with good levels of involvement and communication. Administration and service access remain as leading negative issues.



Information, Involvement and Support

Satisfaction has declined by 1% this quarter, standing at 72% positive, 26% negative and 2% neutral.

Complaints are down by 4% on user involvement and by 2% on support, while increasing by a notable 12% on communication. More on page 5.



Quality and Empathy

Satisfaction has improved by 1% this quarter, at 78% positive and 22% negative.

Good levels of quaility and empathy continue to be reported. More on page 5.



Access to Services

Satisfaction has improved by a notable 9% this quarter, standing at 40% positive and 60% negative.

Complaints are down by 19% on ability to book appointments and by 17% on waiting lists, while increasing marginally by 1% on telephone access. More on page 5.

GP Services

Satisfaction is at 54% positive, 45% negative and 1% neutral, according to feedback.

341 people comment on GP services. The majority of patients receive good quality, compassionate treatment and care. Access related trends are clearly negative overall, this includes on booking processes, telephone access, administration and waiting lists. Patients would also like greater levels of communication. Dentists

Comments suggest satisfaction is at 82% positive and 18% negative.

159 people comment on dentists, with accounts of excellent treatment, care and customer service recorded. Good levels of information and involvement are also reported. More on page 10.




Whipps Cross University Hospital






2. Health and Care Services: Which service aspects are people most commenting on?













3. On the whole, how do people feel about Health and Care services?




3.1 How do people feel about services overall?




3.2 How well informed, involved and supported do people feel?





